Weather

Thunderstorms will continue to move overnight across the state, especially southern Wisconsin. There is a chance for brief, heavy rain. Tomorrow there could be isolated showers in northern Wisconsin. Dry conditions are in the forecast for the next few days.

River Levels

Flood warnings remain in effect for the Baraboo, Pecatonica, Sugar, Kickapoo, and Fox Rivers.

FEMA

Governor Walker today requested FEMA conduct preliminary damage assessments in Kenosha, Racine and Walworth counties for both Individual Assistance and Public Assistance (infrastructure). The teams will arrive in Wisconsin next week. This is the first step for potentially requesting federal assistance. Meanwhile, damage assessments continue in west central and southwest Wisconsin following damaging storms and flooding last week. Governor Walker continues to be updated about the cleanup and recovery efforts in those areas. Damage assessments are just beginning in some of those communities and a decision will be made soon on the next step for assistance.
