Weather

The National Weather Service says Wisconsin will get a break from the rain. The forecast calls for sunshine with highs in the mid 70's to mid 80's through the weekend. We may see some showers and isolated thunderstorms in northern Wisconsin on Monday night. No severe weather is in the forecast through at least the middle of next week.

River Levels

Flood warnings remain in effect for the Baraboo, Pecatonica, Sugar, and Kickapoo Rivers.

FEMA

The Federal Emergency Management Agency (FEMA) will conduct preliminary damage assessments next week in three southeast Wisconsin counties hit hard by flooding earlier this month. FEMA officials will begin looking at flood-damaged homes and public infrastructure in Kenosha, Racine, and Walworth Counties. This is the first step for potentially requesting federal assistance. Meanwhile, damage assessments continue in west central and southwest Wisconsin following damaging storms and flooding last week. Governor Walker continues to be updated about the cleanup and recovery efforts in those areas. A decision will be made soon on the next step for assistance. Home and business owners are urged to notify their county emergency management officials about property damage.
